

आणि जनशताब्दी एक्स्प्रेससह अन्य काही सुपरफास्ट राजापुर व विलवडे स्थानकावर थांबविणे, यांसारखे प्रश्न सध्या तेथील नागरीकांना व ये-जा करणाऱ्या भेडसावत आहेत.

सावंतवाडी, दिवा व रत्नागिरी मडगाव पॅसेंजर तिन्ही स्थानकांवर थांबतात. तर खास कोकणातील असलेल्या जनतेसाठी सुरू कोकणकन्या एक्स्प्रेस आणि तृतारी एक्स्प्रेस राजापुर आणि विलवडे स्थानकावर थांबतात. तर मांडवी एक्स्प्रेस केवळ राजापुर स्थानकावर थांबते. अन्य कोणतीही एक्स्प्रेस अथवा सुपरफास्ट ट्रेन राजापूर वा विलवडे स्थानकावर थांबत नाही.

या तिन्ही स्थानकांपैकी राजापूर रेल्वे स्थानकाकडे सध्या रेल्वेच्या वेळेत मिनीबस सेवा सुरू करण्यात आली आहे. त्यातील काही फेऱ्या बंद करण्यात आल्या. मात्र, विलवडे आणि सौंदळकडे जाण्यासाठी व

येण्यासाठी कोणतीही सोय नाही. त्यामुळे मग १५० रुपयात मुंबईतून गावाकडे येणाऱ्या आणि गावाकडून मुंबईकडे जाणाऱ्या चाकरमान्यांना २०० रुपयांपासून ५०० रुपयांपर्यंत रिक्षा व अन्य खासगी वाहनांना भाडे देऊन घर गाठावे लागत आहे. त्यामुळे मग यापेक्षा एसटी अथवा खासगी बसने आलो असतो, तर बरे झाले असते, अशा प्रतिक्रिया प्रवाशांतून व्यक्त होत आहेत. त्यामुळे हे चित्र कधी बदलणार?

रेल्वे स्थानकांमध्ये अनेक गैयसोयी आहेत. अपुरा प्रकाश, शौचालयांची दुरवस्था, रेल्वे स्थानकावर नसलेले छप्पर या गैरसोयींचा कायमच प्रवाशाना सामना करावा लागतो.

असा जनतेचा सवाल आहे.

# आंबोली घाट वाहतुकीस धोकादायक

सावंतवाडी, दि. ११ - सावंतवाडी आंबोली घाटाला पर्यायी मार्ग म्हणून गेल्या पंधरा वर्षापासून चर्चेत असणारा आंबोली केसरी फणसवडे हा रस्ता शासनाच्या लालिफतीत अडकून पडला आहे. राज्याचे बांधकाम मंत्री छगन भुजबळ असताना सिंधुदुर्ग जिल्हा शेतकरी संघटनेने आणि आंबोली चौकुळ केसरी फणसवडे गावातील शेतकऱ्यांनी ह्या घाटाला पर्याय म्हणून रस्ता काढावा अशी मागणी केली होती. त्या मागणीनुसार तेव्हाच्या मंत्र्यांनी मान्यता देऊन सार्वजनिक बांधकाम खात्याकडून रस्ता पहाणी करुन माहिती घेतली होती व त्याला मंजूरीही दिली होती. पावसाळ्यात घाटातील दरडी

अचानक कोसळत असतात. त्यामुळे कोल्हापूर, बेळगाव, पुणे घाटमाथ्यावरील जिल्ह्यांचा संबंध तुटतो. प्रवाशांची, व्यापारी वर्गाची गैरसोय होते. घाटाला पर्याय नसल्यामुळे आणि घाट दुरुस्ती योग्य प्रकारे केली जात नसल्याने अपघातही होतात. ह्या घाटाने शंभरावी पूर्ण केली असून घाट धोकादायक झालेला आहे. घाटातील मोऱ्यांचे आयुष्य संपले आहे असे ब्रिटीशांचे पत्र ग्रामपंचायत आंबोली यांना प्राप्त झाले आहे. परंतु या पत्राकडे संबंधित खाते गंभीरपणे पाहताना दिसत नाही.

महाराष्ट्र शासनाने ह्या घाटाला पर्यायी रस्ता म्हणून चौकुळ नेनेवाडी फणसवडे केसरी अशी मान्यता दिली. त्यासाठी सर्व्हे करुन त्याचा अहवाल मागविला. सर्व्हे व भूसंपादनासाठी सुमारे ७५ लाख मंजूरही केले. या रस्त्याचा सर्व्हे झाला. पण भूसंपादनाला गती आली नाही. रस्ता वनखात्याच्या जागेतून तीन कि.मी. जाणार आहे. त्यासाठी वनखात्याची परवानगी आवश्यक सा.बां.खात्याने वनविभागाकडे प्रस्ताव पाठवून तो मंजूर करुन घेणे आवश्यक असताना त्यासंबंधी योग्य माहिती दिली जात नाही. तर वनखाते प्रस्ताव नाही म्हणून हात वर करत असल्याचे सांगण्यात येते.

ह्या घाटातून अवजड वाहनाची मोठ्या प्रमणात वाहतुक चालू असते. दिवसाला हजारो लहान-मोठ्या गाड्या ह्या घाटातून वाहत्क करीत असतात. पावसाळ्यात वर्षा पर्यटनाचे आंबोली हे प्रसिद्ध ठिकाण असून गोवा, कर्नाटक, महाराष्ट्र राज्यातील हजारो पर्यटक आपली वाहने घेऊन पर्यटनाचा आनंद लुटण्यासाठी आंबोली घाटात येत असतात. अशावेळी या घाटात दरडी कोसळत असल्यामुळे पर्यटक प्रवाशांच्या

जीवीताला धोका निर्माण झाला आहे. त्यासाठी आंबोली घाटाला पर्यायी रस्ता म्हणून केसरी-फणसवडे ते चौकुळ नेनेवाडी असा २७ कि.मी. पर्यायी रस्ता मंजूर आहे.

सर्व्हे झालेल्या खाजगी जमीन मालकांना या भागात कोणतीही लागवड करता येत नाही. वनखाते प्रस्ताव नसल्यामुळे पुढील कोणतीही कार्यवाही करत नाही. पावसाला सुरुवात झाली आणि घाटात दरड कोसळली की सा.बां. खाते रस्ता वाहत्कीस बंद केल्याचा बोर्ड लावून गप्प बसते. आणि वाहतुकदार वाहनचालकांना हा मार्ग बंद होतो. तेव्हा दोन्ही राज्यांचा संपर्क तुटतो. त्यामुळे भाजीपाला, कडधान्य, कोंबडी, दूध अशा सर्व जीवनावश्यक वस्तू पावसाळ्यात सिंधुदुर्गवासीयांना मिळण्यात अडचणी निर्माण होतात.

गेल्या वर्षी राज्याचे महस्रल मंत्री, बांधकाम मंत्री यांनी पावसाळ्यात दरड कोसळली होती तेव्हा पत्रकार परिषद घेऊन पर्यायी रस्ता चालू करुन देऊ अशा घोषणा केल्या होत्या. मात्र त्याचे पुढे काहीच झाले नाही.

आंबोली पंचक्रोशीतील ग्रामस्थ वेळोवेळी घाटरस्ता दुरुस्त करा, पर्यायी मार्गाला चालना द्या अशी मागणी करीत असतात. मात्र त्याकडे कृणीच लक्ष देत नाही.

हे प्राथमिक आरोग्य केंद्र गेली अनेक वर्षे एका भाड्याच्या घरात आहे. अनेक समस्यांच्या गर्तेत हे आरोग्य केंद्र सापडले असले तरी या सर्व समस्या, अडचणींवर मात करून येथे कार्यरत असलेल्या वैद्यकीय अधिकारी डॉक्टर सायली पाध्ये व

त्यांचे सहकारी कर्मचारी अतिशय दर्जेदार व चांगली सेवा रूग्णांना देत आहेत. उपलब्ध सुविधांमधून जास्तीत जास्त चांगल्या सुविधा रूग्णांना देण्याचा त्यांचा प्रामणिक प्रयत्न आहे. त्यांचा हा प्रयत्न निश्चीतच कौतुकास्पद आहे.

सदर शेतकऱ्यांना तात्काळ वीज जोडणी देणे अपेक्षित होते. मात्र वीज वितरण कार्यालयाने वीज जोडणी करण्यास टाळाटाळ केली. कोटेशन भरलेल्या शेतकऱ्यांनी वीज जोडणीसाठी विद्युत कार्यालयाकडे सतत पाठपुरावा केला; मात्र त्याचा काही उपयोग झाला नाही. आठवडे, महिनेच नव्हेतर आज रोजी तब्बल सहा वर्ष लोटले तरी विद्युत कार्यालयाने सदर शेतकऱ्यांना अजूनही वीज कनेक्शन दिले नाही. याबाबत या शेतकऱ्यांनी वेळोवेळी तक्रारी दाखल केल्या पण, त्यावर कुठलीच कारवाई झाली नाही. कोटेशन भरलेल्या शेतकऱ्यांच्या शेतात विहिरी उपलब्ध असून, विहिरींना मुबलक पाणी सुध्दा आहे. परंतु केवळ शेती पंपाना वीज प्रवठा नसल्याने या शेतकऱ्यांना कोरडवाह शेती करावी लागत आहे. दरम्यान, कोटेशन भरुन वैतागलेल्या शेतकऱ्यांनी या प्रकरणी सखोल चौकशी करुन विद्युत कार्यालयाच्या दोषी अधिकाऱ्यांवर कारवाई करण्याची, तसेच विद्यत प्रवठा देऊन नुकसान भरपाई देण्याची मागणी निवेदनात केली आहे.

या निवेदनावर चापला नाईक तांडा येथील शेतकरी दिनेश राठोड यांच्यासह अनेक शेतकऱ्यांच्या स्वाक्षऱ्या आहेत.

शहापुर तालुका हा धरणाचा तालुका म्हणून ओळखला जातो. या तालुक्यात भातसा, तानसा, वैतरणा अशी मोठी जलाशये आहेत, मात्र आज याच तालुक्यात कधी नव्हे इतकी पाणी टंचाई निर्माण झाली आहे. सध्या तालुक्यात ६७० हातपप आहेत. त्या पैकी ८० टक्के हातपंप सध्या पाणी नसल्याने तर काही मोडकळीला आल्याने बंद आहेत. या वर्षी पाऊस लवकर गेला. त्यामुळे परतीचा पाऊस व जमिनीत मुरणारा व नदी नाले ओढे भरून ठेवणारा पाऊसच न झाल्याने उलट जिमनीवरील पाणी लवकर जिमनीत मुरून जमीन कोरडी पडल्याने पाणी पातळी खोलवर गेली. त्यामुळे ना विहिरींना पाणी ना बोअरवेलींना

आज तालुक्यात १५५ पाणी योजना चालू असून त्यापैकी काही पाण्याचा सोर्स नसल्याने तर काही प्रगती पथावर असल्याने बंद आहेत. मात्र शासनाने त्यावर निधी उपलब्ध केल्यास त्या सुरू होण्यास मदत होईल.

पाणी अशी अवस्था झाली आहे. तालुक्यात ८१२ विहिरी असून आज केवळ जमतेम विहिरींना पाणी आहे. बाकी कोरड्या ठाण पडल्या आहेत. आज तालुक्यात १९३ स्वतंत्र नळ पाणी पुरवठा योजना असून त्यापैकी १५५ पाणी योजना सुरू आहेत. तर ३३ पाणी योजना प्रगती पथावर असल्याची माहिती पाणीपुरवठा विभागाकडून देण्यात आली. म्हणजेच ३३ योजना ह्या कोणत्या ना कोणत्या कारणानी बद आहेत. त्या पैकी काही योजना या जुन्या असल्याने डबघाईला आल्या असून काहींचा वीजपुरवठा खंडित केला आहे. काहींची वीज वाहिन्या त्टल्या आहेत. काहींच्या मोटारी नाद्रुस्त आहेत. तर काहींच्या

मेंटनन्स करणे परवडत नसल्याने तर काहींचे पाइपलाइन चोरून नेल्याने तर काही पाणी नसल्याने बंद आहेत. त्यामुळे पाणी पुरवठा होणे शक्य होत नाही. वाड्या-वस्त्यांवर पाणी टंचाई अधिक प्रमाणात उग्र रूप धारण करत असल्याचे दिसून येत आहे.

तालुक्यात प्रादेशिक नळ पाणी पुरवठा योजनेच्या पाच योजना असून त्याद्वारे ३९ गावांना पाणी पुरवठा सुरू आहे.१६ लहानमोठ्या नळ पाणी योजना आहेत. मात्र त्यापैकीही बऱ्याच पाण्या अभावी बंद असल्याची माहिती पाणी पुरवठा विभागाकडून देण्यात आली आहे. आज तालुक्यात भीषण पाणी टंचाई निर्माण झाली आहे. अजूनही जून महिना यायचा बाकी आहे जून मध्येही पाऊस पडेलच याची शाश्वती नाही. त्यामुळे सध्या तालुक्यात भीषण पाणी टंचाई असून आगामी दिवसात ती अधिक गंभीर होण्याची चिन्हे आहेत.

त्यामुळे पुढे पडणाऱ्या पाऊसाचे पाणी साठून कसे ठेवता येईल तसेच तो जिमनीत कसा मुखता येईल याचे नियोजन करणे महत्वाचे आहे.

गोरगरिबांसाठी शासन वितरण व्यवस्थेमार्फत धान्य पुरवठा केला जातो. मात्र काही कर्मचाऱ्यांना हाताशी धरुन व्यापाऱ्यांनी या धान्याचा काळाबाजार सुरु केला होता. याची कुणकुण लागल्यानंतर पोलीस अधीक्षक मीना यांच्या नेतृत्वाखालील विशेष पथकासह स्थानिक गुन्हे शाखेने गह आणि तांदळाचे काळ्या बाजारात जाणारे दहा ट्रक कुंट्रर ठाण्याच्या हद्दीत पकडले. १७ जुलै २०१८ रोजी रात्री उशिरा ही कारवाई करण्यात आली होती. पकडलेल्या या ट्रकमध्ये कोट्यवधी रूपयांचे धान्य आढळून आले. तसेच कृष्णूर आद्योगिक वसाहतीतील मेगा ॲग्रो अनाज लिमिटेड या कंपनीत विविध राज्यातून आणलेले शासकीय धान्यही मोठ्या प्रमाणात आढळून आले होते. याप्रकरणी कुंट्रर पोलीस ठाण्यात शिवप्रकाश मुळे

यांच्या तक्रारीवरून कंपनीचे मालक अजय बाहेती, कंपनी व्यवस्थापक प्रकाश तापडीया, दहा ट्रक चालक, प्रवठा ठेकेदार आणि ट्रान्सपोर्टर यांच्याविरोधात नियोजनबद्धरित्या कट करुन शासनाची फसवणूक केल्याप्रकरणी गुन्हा दाखल करण्यात आला होता. मागील दहा महिन्यांपासून सदर प्रकरणातील आरोपी पोलिसांना चकवा देत होते. त्यातच आरोपींना काही अधिकाऱ्यांसह राजकीय पुढारीही पाठीशी घालत असल्याचा आरोप होत होता. दरम्यानच्या काळात सदर प्रकरणाचा तपास सीआयडीकडे सोपविण्यात आला. तपास सोपवून काही महिने उलटले तरी कारवाई होत नसल्याने उलट-सुलट चर्चा सुरु असतानाच सीआयडीच्या अधीक्षक लता फड यांच्या नेतृत्वाखालील पथकाने तिघांना नांदेडमधून, तर ललित खुराणा यांना हिंगोलीतून अटक केली. सदर प्रकरण मुंबई उच्च न्यायालयाच्या औरंगाबाद खंडपीठात सुरू असून याप्रकरणाच्या तपासाबाबत न्यायालयाने काही दिवसांपूर्वीच तपास अधिकाऱ्यांवर गंभीर ताशेरे ओढले होते त्यानंतर काही दिवसांतच सीआयडीकडून ही मोठी कारवाई करण्यात आली आहे. लता फड यांच्या नेतृत्वाखाली पोलीस उपअधीक्षक आय.एन.पठाण, आर. के. गुजर, बी. एल. राठोड, पोलीस निरीक्षक बी. एन. आलेवाड, इंगळे, हेकॉ. जमील मिर्झा, आर. आर. सांगळे, आर. एन. स्वामी, एस. व्ही.राचेवार यांच्या पथकाने ही कारवाई केली.
